A code number designating class of membership is placed before each name. These are as follows: 1—active member; 2—associate member; 3—honorary member. This information and all addresses here listed have been taken directly from the addressograph plates used for mailing *Mosquito News*. These were corrected insofar as possible just before going to press, but there are undoubtedly a number of membership designations and addresses which are incorrect, or not given exactly as the member would prefer. There is a tendency for persons not to bother with minor corrections in an address so long as the journal continues to reach them; also it is often some time after corrections, changes, and additional information reach the secretary before they can be added systematically to the file and transferred to the addressograph plates. Therefore it is hoped that members will not be unduly annoyed by errors in the list, but will, rather, cooperate with the secretary and the editor by calling their attention to the desired changes so that corrections can be made.
