MINUTES OF THE 11TH ANNUAL MEETING OF THE AMERICAN MOSQUITO CONTROL ASSOCIATION HELD AT LOS ANGELES, CALIFORNIA, JANUARY 23-27, 1955

RECORDED AND REPORTED BY FRED H. STUTZ

Board of Directors: 8:00 P.M., January 23, 1955. The Board of Directors of the American Mosquito Control Association was convened at 8:00 P.M. January 23, 1955, at the Statler Hotel, the convention headquarters, in Los Angeles, California, by President Dorer.

Those present were: C. R. Twinn, F. C. Bishopp, Don M. Rees, R. F. Peters, R. L. Vannote, L. W. Smith, T. G. Raley, C. M. Gjullin, Wm. E. Bickley, Donald Collins, S. V. Minnich, G. Edwin Washburn, Otto McFeely, Fred H. Stutz and Thomas D. Mulhern and others, who came and left during the meeting.

The first motion was made by Lester W. Smith: That the minutes as published in the June 1954 issue of *Mosquito News* be approved. Seconded by S. V. Minnich and carried.

It was moved by S. V. Minnich that the report of the seminar held at Toledo, Ohio, September 29-October 1, 1954, be approved as submitted. Seconded by Don Rees. Carried. Attachment 1.

President Dorer announced the appointment of the following to the Resolutions Committee: John M. Hirst, Chairman; T. D. Mulhern, and Jack Kimball. He then gave a report. Attachment 2.

President Dorer added that a meeting was to be held the first week in February at Amherst, Massachusetts, for the purpose of organizing a New England Mosquito Control Association; and that Publication #3, "Mosquito Culture Techniques and Experimental Procedures" by Helen Louise T. Durkee is ready for distribution at \$2.00 per copy; that its sale would be handled by C. T. Williamson, Yaphank, L. I., New York.

It was moved by S. V. Minnich that the report of the President be accepted.

Seconded by Lester W. Smith. Carried.

Richard F. Peters moved that a special meeting of the Association be held Monday morning to act on a petition requesting that Harold F. Gray be immediately elected to honorary membership in the Association, and that a special memento be presented to him at the banquet Monday night. Seconded by C. M. Gjullin. Carried. Attachment 3.

Past President F. C. Bishopp, Chairman of the Nominating Committee, presented the report of this committee, and moved its acceptance. Seconded by Otto McFeely. Carried. Attachment 4.

Treasurer L. W. Smith presented a comprehensive financial report of the affairs of the Association. S. V. Minnich moved its acceptance. Seconded by G. E. Washburn. Carried. Attachment 5.

Mr. Smith then read a report for C. T. Williamson on the financial status of AMCA Bulletin 2. It was moved by S. V. Minnich that the report of Mr. Williamson be accepted. Mr. Washburn seconded. Carried. Attachment 6.

A Report on the Examination of the Treasurer's Account was received from Nathan Lipman, CPA. Dr. Bishopp moved the acceptance of the report. Seconded by Otto McFeely. Carried. Attachment 7.

The Treasurer presented a budget estimate for the year 1955. After discussion and modification, it was moved by S. V. Minnich that the attached budget be approved. Seconded by Don Rees. Carried. Attachment 8.

Executive Secretary Raley read a report of the Committee on Bylaws. The report engendered a long discussion but no action. Attachment 9.

Secretary Raley made a report of his

correspondence with the Secretary of the American Association for the Advancement of Science pertaining to the inequalities in pay of the Armed Forces Career Compensation Act. The following is a quotation from the Secretary of the A.A.A.S. dated October 29, 1954:

"Unfortunately, our agenda was an extremely heavy one and so the matter was simply tabled to await a later meeting when we might have an opportunity for a more detailed consideration of whether or not the Association can actively go to work on this problem."

The question of funds available for the payment of Bulletin #3 was discussed. It was brought out that Association funds were being held by members other than the Treasurer, and it was the feeling that all funds such as Good Neighbor, Special Publications Committee, and any other monies held for the benefit of the Association should be turned over to the Treasurer. Richard Peters moved that all funds belonging to or held for the credit or benefit of the Association be turned over to the Treasurer. Seconded by Dr. Bishopp. Carried.

The meeting was adjourned.

SPECIAL BUSINESS MEETING, JANUARY 24, 1955. At the regular Monday morning (January 24) Program Meeting held at 9:50 A.M., President Dorer convened a Special Business Session of the Association to consider a petition requesting that Harold F. Gray be made an honorary member of the AMCA. This was done at a special meeting so that a certificate could be presented to Mr. Gray at the evening banquet. Richard Peters moved that Mr. Harold F. Gray be elected to honorary membership. Don Rees seconded. Carried.

There being no further business, the President adjourned the meeting.

FIRST GENERAL SESSION, MONDAY, JANUARY 24, 2:45 P.M. At the regular Program Session at 2:45 P.M. Monday, January 24, the President announced the report

of the Nominating Committee. No action was necessary.

SECOND GENERAL SESSION, TUESDAY, JANUARY 25. Prior to commencement of the regular afternoon program meeting at 1:40 P.M. Tuesday, January 25, President Dorer convened a business session for the election of officers. The report of the Nominating Committee was re-read. The President called for nominations from the floor. There being none, Robert L. Vannote moved that the nominations be closed. Seconded by Harold F. Gray. Carried.

Dr. L. W. Hackett moved that the Secretary be instructed to cast an unanimous ballot for those nominated. Seconded by George A. Thompson. Carried. Attachment 4.

SECOND MEETING, BOARD OF DIRECTORS, 7:00 P.M., JANUARY 25. The second meeting of the Board of Directors of the American Mosquito Control Association was held at 7:00 P.M. January 25, 1955.

The meeting was called to order by President Dorer. Those present were: T. G. Raley, Lester W. Smith, Dr. Don M. Rees, Richard F. Peters, Dr. B. B. Pepper, G. Edwin Washburn, Fred H. Stutz, Dr. Donald Collins, Robert L. Vannote, C. F. Scheel, and others.

Commander Hirst reported for the Special Publications Committee. Mr. Washburn moved that the committee be thanked for their fine work in publishing Bulletin #3; further, that payment be authorized in the amount of \$1,351.05. Seconded by Dr. Rees. Carried.

Executive Secretary Raley read Report of the Good Neighbor Club AMCA for 1954. Richard Peters moved that the report be accepted and that Miss Helen Sollers be complimented and thanked for her successful efforts in keeping 25 subscriptions going to fellow workers in foreign countries. Seconded by Lester W. Smith. Carried. Attachment 10.

A delegation from Jefferson County, Texas, composed of Dr. Paul R. Meyers, Mr. George A. Thompson, and Mr. Gish, appeared before the Board to request that

the 1956 meeting of the Association be held in Beaumont, Texas, on approximately the 5th, 6th and 7th of February. This is the third year that an invitation has been received from Texas. In view of the mosquito work that is being carried on in Texas, it was felt that the invitation to Beaumont should be accepted. Mr. Washburn moved that the invitation to Beaumont, Texas, be accepted. Seconded by Mr. Stutz. Carried.

The President adjourned the meeting until 9:00 A. M. January 26.

THIRD MEETING, BOARD OF DIRECTORS, 9:25 A.M. JANUARY 26. President Dorer reconvened the meeting of the Board of Directors at 9:25 A.M. January 26, 1955.

Austin Morrill presented the report for the Committee on Research and Development. Lester Smith moved its acceptance. C. M. Gjullin seconded. Carried. Attachment 11.

Richard F. Peters presented report of the Publications Committee. Dr. Collins discussed various aspects of the editing and publication of *Mosquito News*. Dr. Rees made the following motion:

"I move to accept the report of the Publications Committee with a vote of thanks and commendation to members of the Committee, especially sanctioning paragraph three commending Dr. Donald L. Collins, Editor of *Mosquito News*. Also, a sincere vote of thanks to his secretary, Mrs. Margaret Slater for the outstanding service she is rendering AMCA."

Seconded by Lester W. Smith. Carried. Attachment 12.

Otto McFeely presented in writing suggested changes in the format of *Mosquito News*. The material was turned over to the Publications Committee for consideration.

Richard F. Peters moved: That the editor of *Mosquito News* be given authority to permit the reprinting of articles and papers printed in *Mosquito News*, if in his opinion such is desirable; provided, however, that proper credit be given to

Mosquito News. Seconded by S. V. Minnich. Carried.

The matter of the report of the Bylaws Committee was reopened. After discussion, it was moved by Lester W. Smith that the report be accepted and referred to the membership at the general meeting. Seconded by Dr. Rees. Carried.

T. G. Raley made a report for the Membership Committee. He moved that all applicants for active membership be approved. Seconded by Lester W. Smith. Carried. Attachment 13.

Lester W. Smith moved that report of the Membership Committee be accepted. Seconded by Dr. Rees. Carried.

T. G. Raley read the Report of the Committee on Legislation. He moved its acceptance. Seconded by Richard F. Peters. Carried. Attachment 14.

There being no further business to come before the Board, the meeting was adjourned at 11:20 A.M.

THIRD GENERAL SESSION, MAIN BUSINESS SESSION, WEDNESDAY, JANUARY 26, 4:35 P.M. The meeting was called to order at 4:30 P.M. January 26, by President Dorer.

Mr. Washburn moved that the minutes as published in the June 1954 issue of *Mosquito News* be approved. Seconded by Dr. Bishopp. Carried.

Dr. Wm. E. Bickley presented Report on Advertising in *Mosquito News* for the year 1954. Lester W. Smith moved that the report be accepted and that Dr. Bickley be thanked for the outstanding job he did during the past year in increasing the revenue from advertising. Seconded by Commander Hirst. Carried. Attachment 15.

Commander Hirst reported to the membership that Bulletin #3 is ready for distribution. Dr. Bishopp moved that the Committee be thanked for an excellent job. Seconded by Harold F. Gray. Carried.

Dr. Collins discussed *Mosquito News* and gave figures as to the classification of the articles published.

Austin Morrill, Jr. asked that material

suitable for publication in News and Notes be sent to him.

Dr. Pepper read the Report of the Committee on Bylaws. He discussed the report and the articles affected by the recommendations of the Committee. Commander Hirst moved that the report be accepted and that the changes in the bylaws recommended in the report be made at this time. Seconded by Mr. Gray. Carried. Attachment 9.

Secretary Raley moved that the agreement pertaining to the publication of papers to be presented at this joint meeting, which had been previously approved by mail by the Board of Directors, be approved by the membership. Seconded by R. L. Vannote. Carried. Attachment 16.

Secretary Raley moved that motion made and carried by mail ballot for the Association to contribute \$70.00 toward the expense of *Mosquito News* Editor Collins to this meeting be approved. Dr. Bishopp seconded. Carried.

Secretary Raley moved that motion made and carried by mail ballot for the Association to pay the hotel expense of President Dorer be approved. Seconded by Thomas Mulhern. Carried.

Secretary Raley read communications from H. H. Stage, Dr. H. P. S. Gillette, Trinidad, BWI, and Mr. Walter D. Henderson.

He then read the Auditor's Report to the membership. Mr. Mulhern moved its acceptance. Seconded by Richard Peters. Carried.

The Report of the Membership Committee was read. S. V. Minnich moved its acceptance. Seconded by Dr. Pepper. Carried.

Secretary Raley read the Report of the Research and Development Committee and moved its acceptance. Dr. Collins seconded. Carried.

Dr. Twinn moved that the membership compliment Executive Secretary Raley for the very fine job he is doing for the organization. Dr. Bishopp seconded. Carried.

The Secretary announced to the membership that the next meeting would be

held in Beaumont, Texas, about February 5, 1956.

Commander John M. Hirst, Chairman of the Resolutions Committee, presented the following resolutions and moved their adoption. The resolutions were acted upon separately.

WHEREAS, Recent studies show that this disease is spreading where controls are inadequate, therefore

BE IT RESOLVED: That this Association hereby alerts its appropriate committees and all of its members to the need for bringing this threatening condition to the attention of all professional workers and societies and public officials who may be able to aid in the extension of the *Aedes aegypti* mosquito eradication program to all areas where this mosquito species is still prevalent.

WHEREAS, The international vector borne disease control program supported by the United States Government through the Public Health Service, Foreign Operations Administration and agencies of the United Nations such as the World Health Organization and the United Nations Children's Fund have effectively demonstrated the way to a way of life free from vector borne diseases and general improvement of the health and well being of populations of economically underdeveloped countries of the world, therefore

BE IT RESOLVED: That the American Mosquito Control Association expresses

its wholehearted support and encouragement of the future continuation of United States assistance of these international programs.

There being no further business, the President requested Past Presidents Harold F. Gray and Dr. Fred C. Bishop to conduct the new officers to the platform and present them to the membership. Applause. Adjournment.

The approval of the above chairmen was moved by Dr. Rees. Seconded by Mr. Dorer. Carried.

The President appointed Dr. Maurice W. Provost as Chairman of the Research and Development Committee. Mr. Dorer moved that the appointment be approved. Seconded by Mr. Washburn. Carried.

Dr. Rees moved approval of the following appointments by the President: Dr. Archie D. Hess, Chairman Good Neighbor Club; Robert L. Vannote, National Advisor; Dr. Donald L. Collins, Editor of *Mosquito News*; Fred H. Stutz, Chairman Program Committee.

Seconded by R. E. Dorer. Carried.

Treasurer Lester W. Smith recommended the appointment of William Thom as Assistant Treasurer, as provided for in the amended by-laws. Dr. Rees moved his appointment. Seconded by Mr. Washburn. Carried.

President Peters appointed the following members to prepare a history of the American Mosquito Control Association: Harold F. Gray, Robert L. Vannote, Dr. Robert Glasgow, Thomas D. Mulhern, T. G. Raley.

No formal action was necessary.

There being no further business, the President adjourned the meeting.

PRESIDENT'S REPORT TO THE BOARD OF DIRECTORS—A.M.C.A.

January 23, 1955

Members of the Board, it has been a real privilege to serve with you during 1954. The accomplishments of the association, perhaps, have not come up to the high hopes that we held a year ago, but it is good to report that the state of the Association is improved and 1954, while not sensational, has been a year of continuous progress.

The reports to be made later by the various committees and officers will substantiate this fact, and I wish to thank all of you for your fine cooperation and hard work.

Most of you will recall the last annual meeting at Atlantic City, which was one of the best of our annual affairs. The fine cooperation of the New Jersey Association was wonderful, and special commendation should go to Dr. Pepper, Dan Jobbins, Sam Reck and others. You all have received the proceedings of that meeting, which will be a fine addition to your library. At this meeting the Association honored me with the office of President and elected Dick Peters as President-Elect and Fred Stutz as Vice-President. Dick in his official job as Program Chairman has made the arrangements for this meeting. He has done a wonderful job and the next few days will prove this. Fred

Stutz has made a fine recorder. You all recall the minutes Fred made of the New Jersey meeting, which in itself is no small job.

At this point, I would like to comment on your hard working efficient secretary, Ted Raley. Without Ted our association would have a hard time operating. Lester Smith has done a swell job as treasurer. I think the \$4,245.41 balance as of December 31st stands as a tribute to a job well done by Les.

Perhaps the most important function of our association is the publication of *Mosquito News*, and when you say *Mosquito News*, you can't help but think of Don Collins. Doc Bickley, who took over the advertising manager's job when Harry Stage left, has really come through with flying colors. He reports a revenue increase from advertising of approximately \$800.00.

Barney Travis and Bo Hirst have been working hard on the publication of Bulletin No. 3 by Helen Louise Durkee, and it is now ready for distribution. Helen Sollers, a member of the Good Neighbor Club, reports \$126.50 collected for subscriptions for foreign members.

In April, your President attended the meeting of the Florida Anti-Mosquito Association at Naples, Florida. This was an excellent meeting, presided over by Mel Williams. Under the leadership of John Mulrennan, sensational progress is being made in Florida.

On September 29-30 and October 1, under the sponsorship of the A.M.C.A., a seminar on Fogging and Misting was held at Toledo, Ohio. This meeting came about through the efforts of Otto McFeely, Dr. Brockway, Bruce Brockway and Bob Vannote. There were 107 delegates registered from 13 states and Canada. Great interest was shown in an area of the country where our association had not previously been too active. Thanks to the Toledo Sanitary District.

Your President has been a letter writer. It is estimated that approximately 2,000 pieces of mail went out from Norfolk. Ted Raley says this is good.

You will recall the letters to the membership enclosing a return card specifying the types of articles desired in *Mosquito News*. Out of 721 cards sent out, 147 were returned. The answers seemed to indicate a general approval with *Mosquito News* and desire for more operational articles.

Officers of the Association and Committee Chairmen were communicated with early in the year, setting forth their duties and what should be their goals. Perhaps the duties were not too well defined and perhaps the goals were too ambitious. At this point, I would like to commend Otto McFeely for the response he made to the goal set for his region. He was given a goal of 10 new members; 25 were signed up from the North Central Region. This was due to a large extent to the Toledo meeting. It is reported that they have a hot advertiser lined up. His goal in this department was 1 new account. His region has submitted an operation article for *Mosquito News*, which meets his quota. Twenty-five dollars was contributed to the Good Neighbor Club and assistance has been given to organizing the new South Cook District and to reviving the Illinois Mosquito Control Association. Most certainly, Otto has been a working director.

I think the above indicates briefly that progress has been made. It has been through your efforts that this has been possible, and I want to thank you all.

It might be well to state some of the things that I feel should be done in the future:

1. There is a need to rewrite the Constitution and Bylaws incorporating all of the amendments.
2. There is need to define and reorganize the Good Neighbor Club.
3. Consideration might be given to publication of special Bulletin No. 4 on Fogging and Misting.
4. A history of the association should be made, perhaps, by a special committee.
5. Encouragement should be made for more exchange of correspondence between the various officers.

The Nominating Committee for 1955 was appointed by the President and Board of Directors at the Atlantic City meeting in March 1954, and is representative of all 10 regions recognized by the Association as follows: Northeast Region, Mr. Geo. E. Powers; Central East Region, Mrs. Helen Louise (Trembley) Durkee; Southeast Region, Mr. Wm. C. McDuffie; North Central Region, Mr. Franklin C. Wray; Rocky Mountain Region, Mr. Leslie D. Beadle; Pacific Northwest, Dr. Gaines W. Eddy; Mexico, Central and South America and West Indies, Dr. H. P. S. Gillette; Canada, Prof. B. Hocking, Dr. F. C. Bishopp (Chairman).

To insure a completely democratic procedure, each member of the Nominating

Committee was requested by the Chairman to nominate one member of the Association for each office. The results of this canvass were then tabulated and distributed to the committee. Since none of the persons named received a majority, the members of the committee were requested to submit a second ballot naming for each office someone who was nominated for that office in the first ballot. The results of the second ballot were tabulated and distributed to the committee, together with a statement of the names of the members receiving a majority vote for each office. It was necessary to submit a third ballot to obtain a majority for the office of Vice President; also an additional ballot because of the declination of Mr. Otto McFeely who suggested the name of Mr. Charles F. Scheel as Director of the North Central Region. All the nominees have agreed to serve if elected. The list of

nominees, together with the term of office, follows: President, Mr. R. F. Peters, 1 year; President Elect, Mr. Fred Stutz, 1 year; Vice President, Dr. A. W. Lindquist, 1 year; Executive Secretary, Mr. T. G. Raley, 2 years; Treasurer, Mr. L. W. Smith, 2 years; Regional Directors: Northeast Region, Mr. D. M. Jobbins, 2 years; Central East, Mr. D. MacCreary, 2 years; North Central, Mr. Chas. F. Scheel, 2 years; Pacific Southwest, Mr. G. E. Washburn, 2 years; Canada, Mr. A. W. A. Brown, 2 years.

The following elected officers of the Association have one more year to serve to complete their present terms of office as Regional Directors: Southeast, S. V. Minnich; Southwest (Gulf), Carl A. Nau; Rocky Mountain, Don M. Rees; Pacific Northwest, C. M. Gjullin; Mexico, Central and South America, Luis Vargas.

Gentlemen:

We have examined the records of Mr. Lester W. Smith, Metuchen, New Jersey, Treasurer of American Mosquito Control Association for the period from February 1, 1954, to December 31, 1954, and have prepared, without audit verification, the attached summary of his recorded cash receipts and disbursements. (Editor's note: The summary, being in agreement with the treasurer's report, Attachment 5, is not reprinted.)

Pursuant to engagement the examination was limited in its scope, the extent of which is set forth herewith.

All recorded receipts were found to have been properly deposited in bank. All cancelled checks drawn by the Treasurer were inspected by us, and were compared with entries appearing in his cash disbursements journal. Such disbursements were supported by vendors' invoices. Cash on deposit at December 31, 1954 was reconciled with the statement supplied by the bank, and was confirmed to us by letter from the institution.

The scope of our examination did not include verification of members' accounts for dues charged, collected, or unpaid during the above mentioned period; nor did it include confirmation of other revenues which accrued to the Association during the period under review. The Treasurer informed us that the total due to the Association as at December 31, 1954, for 1954 dues and subscriptions, was \$255.00. Also, he stated that the aforesaid dues, together with cash on deposit at the close of the period in the amount of \$4,245.41, constituted all of the assets of the Association in his custody at December 31, 1954. The records show that unpaid charges against the Association as of the above mentioned date totalled \$97.62.

The Minutes of the Association were unavailable for review.

Invoices inspected by us indicate that the following described fidelity bonds should be in force. These bonds were not available for our inspection.

REPORT OF THE COMMITTEE ON BYLAWS

Your Committee on Bylaws recommends the following amendments to the Bylaws of the American Mosquito Control Association as presented in *Mosquito News*, Volume 10, No. 4, December 1950, and amendments adopted by the Association at the 1954 convention as published in *Mosquito News*, Volume 14, No. 2, June 1954.

Article V. Officers of the Association

Section 1. The Board of Directors.

a. *Members of the Board.* The Board of Directors shall consist of one Regional Director for each of the ten regional areas, and eight Directors at large who shall be: (The change here is deleting the word "six" and adding the word "eight" Directors at large.)

(1) The Chairman of the Board and President of the Association.

(2) The President-Elect, who normally ascends to the office of President at the next election. (This item is new.)

(3) The Vice Chairman of the Board and Vice President of the Association. (Modified.)

(4) The Treasurer of the Association.

(5) The Executive Secretary of the Association.

(6) The Recording Secretary of the Association. (New office.)

(7, 8) Remain the same as 5, 6 in the published Bylaws.

b. *Terms of Office.* The terms for which the officers named shall be elected are:

(1) The Chairman of the Board and President of the Association, a one year term of office.

(2) The President-Elect, a one year term of office.

(3) The Vice Chairman of the Board and Vice President of the Association,

a one year term of office. (Duties as Recording Secretary deleted.)

(4) The Treasurer of the Association, a two year term of office.

(5) The Executive Secretary of the Association, a two year term of office.

(6) The Recording Secretary of the Association, a two year term of office, and

(7) Remain same as (5) in published Bylaws.

Article VI. Powers and Duties of Officers

Section 1. Amendments 1954. President-elect.

Delete C which reads: "Shall be Chairman of Program Committee."

Section 2. Vice President.

Delete paragraphs 2 and 3 in published Bylaws which read as follows:

"The Vice President shall serve as Recording Secretary at general conventions in addition to his other duties. He shall be responsible for keeping the Minutes of the Association when assembled in general convention, and of such other meetings as may be held. He shall be responsible for keeping in order, and for compiling from time to time for information of the membership through publication in *Mosquito News*, reports of proceedings derived from such meetings, and from proceedings of the Board of Directors as carried on by correspondence.

"In case the Vice President may be required to perform the duties of President, he may delegate another member of the Board of Directors to act for him as Recording Secretary."

Section 3. Secretaries.

A. *Executive Secretary*

The Executive Secretary of the Association shall have the following duties:

a. As Executive Secretary, he shall be responsible for setting in motion and following through any plans approved by the Board of Directors for:

(1) Current activities

(2) For the further development of the Association, and

(3) For coordinating the objectives, policies, responsibilities and services of the Association.

b. As Secretary of the Corporation, he shall have custody of the seal, and shall execute with the Chairman of the Board (President of the Association) all legal documents of the Association and affix the seal thereto, and in this capacity shall use the title of Secretary of the Corporation.

c. As Secretary of the Association (delete "and Chairman of the Standing Committee on Membership"), he shall:

- (1) (Stands as written.)
- (2) (Stands as written.)
- (3) (Stands as written.)
- (4) (Stands as written.)
- (5) (Delete.)

B. Recording Secretary.

The Recording Secretary shall be responsible for keeping the minutes of the Association when assembled in general convention, and of such other meetings as may be held. He shall be responsible for keeping in order, and for compiling from time to time for information of the membership through publication in *Mosquito News*, reports of proceedings derived from such meetings and from proceedings of the Board of Directors as carried on by correspondence.

Section 4. Treasurer.

Delete Item g which reads, "He shall be Chairman of the Finance Committee."

Section 6. Board of Directors.

Add Item O as follows: May appoint an Assistant Treasurer upon the recommendation of the Treasurer and may appoint other assistant officers if the demand for such is justified.

Article VII. Nomination of Officers

Section 4. The report of the Nominating Committee shall be presented at a

preliminary business meeting of the Association and nominations from the floor shall be made at the same time. Voting for the candidates shall be held at the regular business meeting of the Association.

Article VIII. Convention and Election of Officers

Section 2.

a. Unless the candidates for offices to be filled by election at a convention are unanimously accepted, either together or singly, by the convention as presented by the Committee on Nominations, the election shall be by ballot. Balloting, if employed, shall be at the regular business meeting of the Association.

The Committee on Bylaws further recommends that the Bylaws be brought up to date and rewritten so that the wording of each section conforms to that of all other sections.

AMCA, FOR 1954

Many members of the AMCA have contributed to the Good Neighbor Club and unfortunately most of them must remain anonymous. We refer to the \$51.50 collected, rather painlessly, during a social hour at the Annual Meeting in Atlantic City. To all of these anonymous contributors we want to extend our thanks.

The money got us off to a good start on the 25 annual subscriptions we send to foreign countries.

However, as this amount was insufficient, late in the summer we sent out about 70 letters to members asking for contributions to raise an additional \$73.50 to complete the goal of \$125.00. In response to the request, \$75.00 arrived due to the generosity of the following members: William H. Arendt, Fred Stutz, F. C. Bishopp, H. H. Stage, Harold Gray, Richard F. Peters, Helen Sollers, Chemical Insecticide Corporation of New York, and the Desplaines Valley Mosquito Abatement District of Lyons, Illinois. All contributed \$5.00 each, except Harry Stage and the Chemical Insecticide Corp., both of whom gave \$10.00 each, and the Desplaines Valley Mosquito Abatement District, who contributed \$25.00. The Committee is most grateful for all of these gifts.

But next year is not far from us and if we are to keep our 25 Good Neighbor subscriptions active, we must raise another \$125.00. The Treasurer now has on hand \$1.50 toward the 1956 subscriptions. This money was left over from the \$75.00, as we only needed \$73.50.

Just a word about the recipients of our subscriptions. They are most grateful for the good will of the AMCA. While most are financially unable to purchase subscriptions, some, regardless of their finances, cannot obtain dollars in their country.

A.M.C.A. SPECIAL COMMITTEE ON RESEARCH AND DEVELOPMENT REPORT FOR 1954-55

The 1953-54 report of this committee dwelt at length with the terms of reference and interpretation of duties of the committee. Again, it is reported with regret that it has been impossible for the committee to meet as a body, and that during the past nine months relatively little has been accomplished by correspondence. During the past eight months your Chairman and one committeeman have been associated. The present report is largely the views of these two individuals.

The 1953-54 report included several suggestions which were deemed worthy of consideration by your executive. Your committee is unaware that any action has been taken. These suggestions, namely: (1) establishment of a file in which the current activities and interests of AMCA members are listed and coordinated; (2) establishment of a roster of research and control projects; and (3) the establishment and maintenance of a list of species of medically important arthropods, which are reared in laboratories, considered by your present committee to be of value still. It is hoped that further consideration can be given to these proposals during the coming year.

Recently your committee has been in correspondence with Dr. E. W. Huffman at the Ohio State University. Dr. Huffman is collecting information on arthropod colonies being maintained in various centers in the United States and Canada. It appears that this compilation may fulfill the suggestion made by this committee. A note on the progress of this project will be submitted to *Mosquito News* at a later date.

Another suggestion in the last report concerned an annual review of a topic of interest to AMCA members. The annual meetings continue to offer the opportunity for the presentation of invitation papers and symposia which would fulfill this

need. It is gratifying to find that several symposia and a number of invitational papers are scheduled for the Los Angeles meetings.

Although recently there has been a curtailment in research activities relating to mosquitoes, both in the U. S. Public Health Service and in the U. S. Department of Agriculture, the work to be done remains. If we can assume, optimistically, that this curtailment is a temporary one, a need will exist for trained researchers. All members of the AMCA can do a service by encouraging promising students to enter the field of mosquito control and research or of research in the broader field of medical entomology.

REPORT OF A.M.C.A. PUBLICATIONS COMMITTEE ON PUBLICATION OF
Mosquito News

Extremely little activity is the essence of the report of the Publications Committee for the year 1954. The following three matters seem worthy of record:

1. Rowland E. Dorer, President of the American Mosquito Control Association, Inc., conducted a card survey of the Association membership inquiring into the desire of the membership with respect to the subject matter content of *Mosquito News*. Each individual was urged to mark "research and development" or "operations" or "political management" or "other specific interests." This survey netted the following replies:

Research and Development	48

Research and Development and Operations	53
Research and Development and Political Management	None

Operations and Political Management	4
Research and Development, Operations and Political Management	19
Suggestions for Articles	50

President Dorer interpreted the above as an indication of the membership showing a "considerable interest in operation articles." The Committee, largely by silent concurrence with the opinion of the Chairman, seems to be satisfied with *Mosquito News* in its current form, this implying that its present composition would seem to conform to the results of the survey made.

2. On the basis of initiative taken by the Committee Chairman who also served as Program Chairman for the 1955 Conference through the office of President-Elect, recommendation was made to the Board of Directors that the following plan be utilized with respect to publication of the Proceedings and Papers of the Eleventh Annual A.M.C.A. Conference:

All invitational papers and the papers and proceedings of the symposia will be printed in the Proceedings and papers of the 23rd (1955) Annual Conference of the California Mosquito Control Association, Inc., to be financed and published by the California Mosquito Control Association, Inc., as a joint publication of both Associations.

Any member of the American Mosquito Control Association, Inc., may present and/or submit a paper for publication, provided that all submitted papers be 700 words or less as a prerequisite to publication, or that in lieu, abstracts of submitted papers, prepared by the author, may not exceed 700 words; however, publication of submitted papers within the California Proceedings and Papers is optional to the author.

Copy of the Proceedings and Papers of the 23rd (1955) Annual Conference of the California Mosquito Control Association, Inc., held jointly with the Annual Conference of the American Mosquito Control Association, Inc., will be furnished each member of the American Mosquito Control Association, Inc.

This plan, presented to the Board of Directors as a motion, was duly passed by unanimous vote.

3. It is the opinion of the Committee that the Association is indeed fortunate to have Dr. Donald L. Collins as its Editor of *Mosquito News*. His clearly demonstrated proficiency and diligence in this important job entitle him to more than passive resignation as Editor for the coming year. He should be resoundingly commended for his outstanding service and highly professional attainment.

A.M.C.A. MEMBERSHIP COMMITTEE REPORT FOR 1954

Membership and subscriptions to *Mosquito News* reached a new high in 1954. The December issue of *Mosquito News* was mailed to 1111 accounts. This is in favorable contrast to the 1953 number which was mailed to only 1,038. In both instances more than one copy was sent to a few addresses but this would not change the total number of individuals and agencies receiving *Mosquito News* very much. A nice round figure of 1,100 is more than safe and there is every reason to believe this can be 1,200 in 1956. Even 1,300 is possible if each member will make just a feeble effort.

Records on new accounts have been adjusted to the annual meetings rather than the calendar year. Between February 1, 1954 through January 14, 1955 there were 156 new accounts added to the mailing list. An even 100 new members joined the Association and 56 subscriptions were ordered. Cancellations took their toll, 87 accounts, but were not unusual. This left a net gain of 69 which is gratifying. The challenge for 1955 is to reduce the cancellation figure from the usual to a near minus. A few accounts will be dropped due to circumstances beyond anyone's control but most accounts are lost because

someone failed to do his part. An all out effort will be made this year to keep each region cancellation conscious. Please don't throw the material you receive on this subject in file 13.

Payment of dues also reached an all time high in 1954. The Treasurer's report for February 1 to December 31, 1954 shows \$4,027.48 had been received. This represents payment for 906 accounts which added to the Exchange and Honorary accounts makes a total of 930 in good standing. Available records show 133 accounts on the mailing list still delinquent for 1954. Some of these may have been paid through the Treasurer's office since his last memo, and of course many will probably pay for both 1954 and 1955 when they receive a statement. Any discrepancy between the 1,063 shown in this paragraph and the 1,111 in the first paragraph is due to different periods of time.

A breakdown of the 1,111 accounts on December's mailing list shows:

From information received on the distribution of the 1954 joint proceedings, 270 *Mosquito News* accounts are outside the United States. Canada leads this list with 45, Venezuela is next with 19, Thailand receives 14, England 13, India 12. In all, *Mosquito News* is read in 73 countries as well as in the United States.

In the United States, California leads the list with 150, New Jersey is next with 105, New York 73, Florida 57, Illinois 50, Utah 39, Maryland 38, District of Columbia 36, Virginia 35. Forty-three states and the District of Columbia receive one or more copies of *Mosquito News*.

New accounts since February 1, 1954 have been processed as they were received. Unanimous approval by the Board of Directors is recommended for all requesting the classification of Active Member.

REPORT OF THE COMMITTEE ON
LEGISLATION

New legislation specifically relating to mosquito control problems has not been noted or called to the attention of the Committee on Legislation. Several legislative items during 1954 which are somewhat indirectly related to mosquito problems are of interest.

A bill before the Illinois State Legislature during 1953 which would have permitted any part of an established mosquito control district to secede from the control district caused some concern to mosquito control workers. Fortunately, as reported by Mr. Otto McFeeley, President of the Desplaines Valley Mosquito Abatement District, the bill died in committee.

There is a definite trend towards legislation in various states to license and regulate the work of pest control operators. Such legislation was put into effect in the State of Kansas about one year ago. Certain states now have regulations relating to pest control services, and others are considering such regulations.

The commercial pest control industry at this time is not highly active in work relating to mosquito control but no doubt will play a more prominent role in this field in the future. No study has been made of the kinds of legislation that have been adopted in various states. Rather complete information relating to this could, no doubt, be obtained from the Secretary of the National Pest Control Association if it would be of interest to mosquito workers.

Passage during 1954 of the Miller Pesticide Residue Amendment (H.R. 7125) to the Food, Drug and Cosmetic Act of 1938, although affecting mosquito control operators indirectly for the most part, is without doubt the most important legislation relating to pest control which appeared during 1954. This amendment establishes procedures for regulating pesticide residues in foods.

The long drawn out and costly hearings to establish tolerances for pesticidal residues in foods which were held in the past by the Federal Security Agency, and the subsequent delays in setting tolerances were recognized by all concerned as being impractical under modern conditions of insecticide development and use. The Miller amendment which outlines specific procedures for establishing tolerances, with specified time limitations to establish such tolerances, apparently received the support of the Department of Health, Education and Welfare, the U. S. Department of Agriculture, and other governmental agencies which have major responsibility in enforcing the amendment. The bill also met the approval of the pesticide industry, agricultural experiment stations and other agencies. This is a good example of legislation which was developed through the cooperative efforts of various segments of industry and the governmental and state agencies directly concerned.

The Department of Health, Education, and Welfare published proposed tolerances for certain pesticides in the October 20, 1954, issue of the Federal Register. The tolerances on a wide variety of pesticides on fresh fruits and vegetables were proposed after several years' delay after hearings were held. It should be emphasized that the tolerances as published were proposals only, and based on toxicity information available in 1950.

The tolerances when finally established will probably not have a great effect on mosquito control programs since mosquito control in situations where fruits and vegetables might become contaminated fortunately represent only a small fraction of the overall operations. However, mosquito control agencies are often faced with delicate operations under circumstances where foods might become contaminated with the chemicals employed. The establishment of tolerances (or exemption from tolerances in the case of pyrethrins, and certain other compounds) should make it possible to select insecticides which can be employed without exceeding tolerances.

Fortunately the per acre dosages employed for effective mosquito control are often considerably lower than those employed for the same insecticide which necessitate direct application to food crops.

The report as submitted is based in part on information supplied by committee members. The report, however, has not been submitted for review to members. Therefore, it cannot be regarded as an approved committee report unless it has the concurrence of the required number of other committee members.
