## A REQUEST FOR PHOTOS OF YOUR EQUIPMENT!

Mr. Fred H. Stutz, President-elect and Chairman of the Program Committee, has set aside 40 minutes at the coming annual meeting in Beaumont, Texas, for a showing of photographs in the form of 2"  $\times$  2" slides of equipment in use by mosquito control agencies in their "source reduction" programs. Such items as crane excavators, ditching plows or other ditching machines, earth movers, engineering equipment, etc., would be included. Standard, commercially available equipment would be appropriate, and it is especially desired that there be complete representation of custom-made or locally built and modified equipment that has been adapted for mosquito control. There are many such units in use, which reflect the originality and ingenuity of mosquito workers in meeting their individual problems, and it is hoped that this portion of the program will bring these good developments to the attention of other agencies which have similar needs.

It is hoped that many of the agencies which submit photos will also have representatives at the meeting, in which case these representatives will be asked to discuss briefly their own equipment items.

Your cooperation in submitting photos can make this part of the program a success. If a member has slides, but cannot be present, and is willing to send them in for showing, they should be sent to Thomas D.
