Mosquitoes Out?—Significant results may be expected from a vast operation aimed at complete eradication of malaria-carrying mosquitoes on the island of Sardinia, off the coast of Italy, Quietly sponsored by the Rockefeller Foundation, this \$12,000,000 experiment—financed in large part by Italian funds set aside under the Marshall Plan—combines fully mechanized operations with the refinements of scientific control. A path to rich developments in tropical areas may be cleared by the techniques and methods perfected.—W. Thom, Eng. News Record, Nov. 18, 1948.

MOUNT VERNON MAD FORMED IN PLACER COUNTY DURING APRIL. It has been recently discovered that a new mosquito abatement district was formed in California, called the Mt. Vernon MAD. The district is approximately 50 square miles in area and includes Penryn, of historical importance in California malarial control.

James Zetek Receives Decoration. The Republic of Panama has conferred its highest award, the Vasco Nuñez Balboa decoration, on James Zetek of the Bureau of Entomology and Plant Quarantine who did some of the early work on the malaria mosquitoes of that country and the Canal Zone.

Mr. Zetek has worked in the Canal Zone and the Republic of Panama for 38 years and is the most widely known and best informed scientist in that region. In addition to his work on mosquitoes, he has conducted research on many problems and as resident manager of the Barro Colorado Island natural history preserve and scientific laboratory has done much to promote interest of scientists of many disciplines in the biology of Central America.

DARLING FOUNDATION TO BE ADMINISTERED BY WORLD HEALTH ORGANIZATION. The Darling Foundation and International Malaria Prize was created by private funds in 1925 in memory of Dr. Samuel T. Darling who was accidentally killed while on a mission for the League of Nations Malaria Commission.

The Darling Fund is to be administered henceforth by WHO, and the Expert Committee on Malaria of WHO is to prepare new statutes for the foundation and will recommend to WHO a candidate for the medal and prize which is awarded periodically to the author of an original contribution to the pathology or prophylaxis of malaria.

Col. S. P. James was the recipient of the award in 1934 and Dr. N. H. Swellengrebel in 1937.

The Virginia Mosquito Control Association held its Second Annual Convention, Friday, January 28, 1949, at Old Point Comfort, Va. It was our privilege to be among the approximately 200 members and guests present when President Perry W. Ruth called the meeting to order in the Hotel Chamberlin.

The morning session included the Presidential Address, as well as addresses by high-ranking navy and army officers from the military installations which are so numerous and extensive in that section of Tidewater Virginia. These men stressed the value to mosquito control of cooperation between military and civilian personnel, and expressed appreciation of the work being done by the Virginia Association. The President of the Federation of Garden Clubs of Norfolk and Vicinity presented an outstanding paper entitled, "Mutual relations of Women's Clubs and mosquito control activities."

Luncheon in the Virginia Room was highlighted by the presence of the Hon. Wm. M. Tuck, Governor of the Commonwealth of Virginia. Governor Tuck is a genial man and an enthusiastic speaker, and he gave to the assemblage the feeling that mosquito control has in him a staunch ally.

In the afternoon, technical papers predominated. Some titles were: "A resumé of mosquitoes trapped in 1948"; "Plans for the study of the effect of DDT on blue crabs"; "The jeep as a vehicle for mosquito control"; "A new nozzle for catch basin spraying"; and "The use of small pressure sprayers in mosquito control."
