It seems that Griseb.'s plant is quite in Ed. 2. of Spec. Plant. I add it is: *Yucca* foliis serrato - filiformis & difficult to say, why serrato, unless the youngest ^{not} filaments near the concave tip of the leaves are compared to serratures.

Dear Gray

You will receive ^{from} my reliance on Dr. Nuttall or your specimen. This morning your letters this evening the package! With dispatch I wish, I could add : neatness! but oh - what an idea - to slice small twigs and press (or not press) big cones - horrid! Hope, the other plants, are better - or I wish to be excused from buying hay!

The Doctor Nuttall, of Penn., is excellent as the fir - Marsteller! All looks so distinct, and like any I have seen - but how characterize it? They are really difficult things. It seems now to me as if *A. oxyodonta* had a structure of wood different from any American species, and if I am right, quite peculiar.

Wright's *Succulaceae* have the printed list of 1865 - there is nothing new among them, as the two species represented have been sent by him before from Cuba.

As the quantity is quite small, I do not suppose that Wright sent me only enough to identify the species, and you had the balance. And I suppose you do have them.

I have ransacked all my Linnean papers, but can not find such a list of Woods - specimens. It is barely possible that it is out at Shaw's where I have, years ago, brought the specimens themselves (all boxed up!). Will look as soon as I can.

By the way, I had a letter of Linnean for 10 or 12 months, though I have written, but know, from his paper, that he lives. Will try to stir him up in a month or two, when Phlox & Linum may be collected.

Why that broad-leaved Yucca is generally accepted as *Y. filamentosa* I do not know, but thus it is. *

No Harry and Redouté or Trew

but I wish you would ascertain some time or other.

* May it not be the same with *Oenothera vulgaris*? What I take to be such, occurs common in Paraguay, in cult. & naturalized while possibly it may not be the original plant.

I must have given Wright the names of his older Cuban Linnæaceæ years ago. If he should not have them I can write them out again for him.

I am glad that you have concluded to lighten your labor and hope it will be done satisfactorily. But can you remain in your house & herbarium in that case?

"Perspicuity" is a good word! ^{of course}
